### **CONTEST TERMS & CONDITIONS**

The JET, SET & SHOP (the "Contest") is being held by ACE CASINO BLACKFOOT and the Alberta Gaming, Liquor and Cannabis Commission ("AGLC").

ACE CASINO BLACKFOOT and AGLC is holding this Contest as part of their Winner's Edge loyalty program for members who play using their Winner's Edge Cards and qualify via slot machines to electronic table games at ACE CASINO BLACKFOOT.

The Contest is open to qualifying members of the Winner's Edge loyalty program who are eighteen (18) years of age or older (each considered a "Contestant") except for employees of AGLC and affiliated advertising agencies. Registered gaming workers, casino facility directors, shareholders, managers, and facility employees are prohibited from entering the Contest. Self-excluded players are also not eligible to participate in the Contest. Verification will be made upon the winning Contestant (the "Contest Winner") ensuring they do not fall into the criteria above.

The Contest entry period (the "Contest Period") runs from FEBRUARY 16, 2026 9am to MARCH 31, 2026 12:01am Mountain Standard Time (MST). All Entries must be received on or before MARCH 31, 12:01am Mountain Standard Time (MST).

There are six ways that a Contestant can enter at ACE CASINO BLACKFOOT:

1. Contestants will automatically earn one (1) ballot into the Contest for every fifty (50) Winner's Edge base points that they accumulate through carded play on slot machines or electronic table games at ACE CASINO BLACKFOOT during the Contest Period. Bonus points earned through special promotions do not count toward Contest entries.
2. Contestants receive one (1) free ballot into the Contest upon the first card-in at a slot machine or electronic table game per day when using their Winner's Edge card during the Contest Period – no play required.
3. Contestants will receive 10x ballots every Monday during the Contest Period, which are earned at a rate of one bonus ballot for every \$5.55 total in cash wagered (with a minimum requirement of \$50 total cash wagered).
4. Contestants will receive 2x ballots every Tuesday during the Contest Period, which are earned at a rate of one bonus ballot for every \$50 total in cash wagered (with a minimum requirement of \$50 total cash wagered).
5. Contestants may redeem fifty (50) points from their Winner's Edge member account for one (1) ballot entry into the Contest through a Winner's Edge kiosk at ACE CASINO BLACKFOOT.



6. Contestants will receive 20x ballots every WEDNESDAY as a limited time offer only during the Contest promotional dates.

Ballots are only valid during the Contest Period.

There will be three (3) grand prizes (the "Prize") valued at \$5000 (Canadian dollars) to the Contest Winner:

- \$4000 WEST JET GIFT CARD & \$1000 PRE-PAID VISA valued at approx. \$5000

Maximum one (1) Prize per person. Once an entrant has won any Prize, they are no longer eligible for any other prizes in this Contest. All ballots ("Entries") have an equal chance of winning for each draw. Chances of winning are dependent on how many Entries are received into the Contest. ACE CASINO BLACKFOOT is to be the executor of the official Prize draw. The Contest Winner will be randomly drawn from all Entries. The draws will take place at approximately 4:00 p.m. MST on MARCH 31, 2026 at the AGLC Office in St Albert, Alberta.

ACE CASINO BLACKFOOT will contact the Contest Winner through the contact phone number or email address provided during member enrollment into the Winner's Edge program. If for any reason it is not possible within a seventy-two (72) hour period to contact the Contest Winner despite customary efforts, AGLC reserves the right to disqualify that Entry and randomly select another Entry as that month's Contest Winner. In the event that the Contest Winner is ineligible, disqualified, does not claim the Prize, is un-contactable for any reason and/or deemed to have forfeited all rights to the Prize, AGLC at its sole discretion may decide if a replacement Contest Winner should be selected.

The name on the Contest Winner's ID must match the name on the winning Winner's Edge account/card. To claim the prize, a valid government-issued photo identification (acceptable to the ACE CASINO BLACKFOOT) is required. The Contest Winner will be required to successfully complete a mathematical skill testing question and sign a Contest Prize Acknowledgement and Release Form before the Prize will be awarded.
